Summary

This report seeks Council's endorsement to provide sponsorship to FootGolf Australia and the Jamberoo Golf Club for three of the Federation for International FootGolf World Tour competitions which will be held at Jamberoo Golf Club.

Finance

Sponsorship of \$9000 is being sought and would be funded from the Contributions and Donations (Events & Festivals) budget.

RECOMMENDATION

That Council become the major sponsor of the three Federation of International FootGolf World Tour competitions being held at Jamberoo Golf Club in 2017 and provide \$9000 sponsorship to FootGolf Australia and the Jamberoo Golf Club.

BACKGROUND

FootGolf is the result of combining the popular sports of football (soccer) and golf. This relatively new sport is rapidly expanding across the globe with deep roots in many countries, including UK (100+ courses) and USA (400+ courses). In 2016, together with players from 26 countries, Australian players participated in the second World Cup in Argentina and the first Asia Cup in China.

FootGolf Australia is a non-profit Organisation developing the sport of FootGolf nationally and is the exclusive member of the Federation for International FootGolf in Australia.

15.1 FootGolf Australia - Request for Sponsorship (cont)

Jamberoo Golf Club initially implemented a 9-hole course in early 2016 and in May 2016 hosted the inaugural Australian Open FootGolf competition for which Council provided \$2500 sponsorship. The event proved very successful and FootGolf at Jamberoo has become a popular sport attracting new members and casual players to the Club. This in turn has been a major contributor to the Club's financial viability with the Golf Club recouping their initial setup costs within six months and the Board deciding to continue to offer FootGolf and extend the course to 18 holes.

FootGolf is a unique tourist and sporting attraction in the Illawarra and South Coast areas.

Jamberoo Golf Club has again been selected to hold the Australian Open this November as well as two preliminary events in July and September.

Jamberoo Golf Club advise that there has been an increase in overnight and day visitors to Jamberoo for footgolf and FootGolf Australia estimate that with minimum event numbers of 24, 36 and 72 players for each of the three events that direct benefits to the Jamberoo economy for the three events would be in the vicinity of \$40,000.

FootGolf Australia has secured the participation in the Open of two of the top 20 players in the world, Matias Perrone and Sebastian Pelliccioni, who are major draw cards for the event and following last year's event have ranked Jamberoo Golf Club as one of the top 5 in the world. Both players provide indirect benefits through attracting media exposure.

Costs associated with being part of the World Tour include player facilities, signage and promotion and the costs associated with bringing the two international players to Australia have increased since 2016 and for these reasons FootGolf Australia are requesting

FootGolf Australia have advised that in return for becoming a major sponsor of the three events, Kiama Council in return will receive:

- Council logo on the main competition media wall
- All media coverage to mention Kiama Council as main sponsor
- Kiama Council listed as main sponsor on website and in social media
- Council logo to be included in Australian Open FootGolf Series promotional video and official video of the competition
- A footgolf corporate day for Kiama Council

Tourism forecasts for this event would see an economic impact to the area of:

- Direct increase in output (purchase of goods and services) of approx. \$0.126M over the three events
- Increase in value-add up to approx. \$0.061M

This is a significant boost to the local economy and particularly that of Jamberoo and will provide a positive benefit.

Given the benefits associated with the three events, it is recommended that Council support the request for a \$9000 sponsorship from FootGolf Australia and Jamberoo

Golf Club for the three events and further advise FootGolf Australia and Jamberoo Gold Club that this is not to be considered ongoing sponsorship.

Australian Open FootGolf Series | Kiama Council Sponsorship

Background of the event

After co-organising the first Australian Open FootGolf with Jamberoo Golf Club and having Kiama Municipal Council as the main sponsor, FootGolf Australia and Jamberoo Golf Club are organising three of the Federation for International FootGolf World Tour competitions in Australia:

- FIFG 50 July 2017
- FIFG 100 October 2017
- FIFG 500 November 2017 (this is the most important event in the Open Series in Australia in 2017)



The first two competitions will be played by Australian players, while the FIFG 500 will have participants from three continents: the Americas, Asia and Europe.

This is a considerable growth from the first year of the competition, showing the development of the sport as well as the increasing recognition of Kiama and Jamberoo Golf Club as a must-go in the world of FootGolf.

Benefits for the local economy

Direct

The direct economic impact of these events is players' expenditure in green fees, accommodation, meals and local attractions. The minimum number of players required for each of the competitions are: 24 players in a FIFG 50, 36 players in a FIFG 100 and 72 players in a FIFG 500. The FIFG 500 is a 3-day event, guaranteeing a minimum of three nights stay for all players. We estimate a direct economic benefit in excess of \$40,000 for the local economy.

Indirect

In 2016, FootGolf Australia sponsored Matías Perrone and Sebastián Pelliccioni, two of the top 20 players in the world to participate in the Australian Open. Both players became loud advocates of Jamberoo Golf Club. Matías mentions Jamberoo Golf Club FootGolf Course as one of the top 5 in the world. It is worth mentioning Matias, is the most travelled and one of the most influential FootGolf players in the world.

FootGolf Australia has already secured the participation of both Matías and Sebastián in the 2017 Australian Open FootGolf by covering their travelling expenses.

Another indirect benefit comes from media exposure related to FootGolf in general. The most recent media coverage was a 3-minute piece on FootGolf at Jamberoo Golf Club on a Getaway episode (https://goo.gl/Exo4Qu).

RECOMMENDED

That Council acknowledge the passing of former Town Clerk, Tony Matterson, with a minute's silence.

REPORT

On Thursday last week it was my sad duty to attend the funeral of the former Town Clerk, George W (Tony) Matterson. Tony died earlier that week after suffering a fall and being hospitalized; he was 89.

Tony served as Town Clerk (General Manager) of Kiama Municipal Council from November 1973 to January 1987 and during this period he significantly improved the financial position of the Council and oversaw the development of major community infrastructure including a new Council Administration Centre, Leisure Centre and the Blue Haven Retirement Village comprising a 52 bed aged care facility and 51 independent living units.

Not only was Tony a well-respected and fair General Manager but also a well-respected member of the community. Following his retirement in 1987 he took on a volunteer role on the Board of Blue Haven on which he served until 2006.

Our thoughts and prayers go to Tony's family at this sad time.
