# **BACKGROUND**

Council has recently received a request from the Kiama Welcomes Refugees Committee to contribute towards the hall hire, projectionist and waste costs associated with running a movie night at Gerringong Town Hall on 20 October 2017.

The movie being shown on the night is Hope Road – a story about a refugee from the Sudanese civil war who takes on a 40-day charity walk to raise funds to help support his village in South Sudan. The movie will be followed by a light supper.

All profits from the movie night will go towards strategically providing community assistance to refugee families in the Illawarra.

- 4. On receipt of the Gateway Determination, proceed with recommendations including requesting any further studies and public exhibition.
