GENERAL MANAGER'S RESPONSE

The CCTV tenders were called and a pre-tender meeting was subsequently attended by 32 people. Tenders close on 8th December 2014. It is not considered to be possible to thoroughly review the tenders in time for a report to the Council meeting of 16th December 2014. The next scheduled meeting of Council is on 10th February 2015. As a matter of practice tenders of this value would normally be reported to Council however the motion proposed by Councillor Seage will allow the tender to be determined as soon as possible therefore avoiding any further delay with the project.
