1. approve Development Application No 10.2021.282.1 at 18 Belinda Street, Gerringong subject to the conditions of consent as attached to this report and including a condition of consent that requires the installation by the applicant of a 1.8 metre high fence along the eastern boundary of the site

- 2. advise persons who made a submission to Development Application No 10.2021.282.1 of Council's decision
- 3. acknowledges community concerns about parking and traffic management during the development of the site and the operation of the site. Council will undertake an investigation of traffic and parking management on Belinda Street and surrounds, following 12 months after site is open for commercial operation.
- 4. add a further condition of the consent which would clarify the expected performance and minimise environmental fumes and odours associated with the operation of the smokehouse as determined by the legislation described on page 77.
