REPORT

Gerringong hockey player, Grace Stewart, recently competed at the 2016 Rio Olympics as a member of the Hockeyroo squad.

Grace was selected earlier in the year to become part of the Hockeyroos and put in a brilliant performance at the 2016 International Tri-Series where she scored Australia's only goal and secured a draw against Germany in the opening game. It was this debut performance that lead to her regular inclusion in the team and helped cement her place in the Hockeyroo's Olympic squad.

A graduate of the Illawarra Academy of Sport, Grace has been playing hockey since she was 5 years old and has represented at regional, state, national and international levels culminating in her inclusion in the Australian team for the Rio 2016 Olympics where she played with her usual skill and determination.
